FLINDERS QUARTET INC. FINANCIAL REPORT 2 September 2020

PURPOSE:

To provide the Board an update on the 2020 financial forecast, including the impact resulting from COVID-19 on Flinders Quartet Inc.

SUMMARY:

- The updated 2020 Forecast presents a net surplus of \$103,987 including all known impacts of COVID-19. This is a \$14,821 improvement from the previous financial report, resulting from COVID-19 relief measure extensions (Victorian Business Support Fund and ATO's cash flow boost).
- 2. JobKeeper benefit to 27 September 2020 is reflected in the forecast with a conservative \$40,000 positive impact. Based on current revenue it is unlikely that FQ will qualify for the October-December 2020 JobKeeper extension, so no additional revenue is incorporated into the 2020 forecast. However we will still assess the turnover once the September quarter closes and will apply for the extension if we can prove the required decline in turnover.
- 3. Philanthropy target amount for the remainder of 2020 is \$9,000; comprising an anticipated \$7,500 donation from Harold Mitchell (donated anonymously), and a further \$1,500 target.
- 4. Despite the unlikelihood of any October concerts proceeding, the MRC, Bendigo and Elgee Park concerts have not yet been cancelled by the venues. Income and expenditure for those concerts remain in the forecast. If (when) they are cancelled, it will have a net negative impact on the forecast of \$4.666.
- 5. While cashflow is currently extremely positive and meets requirements in the short term further work is required to ensure going concern assessments will be met at year end and into 2021.

ADDITIONAL INFORMATION:

6. Philanthropy amounts as outlined in the table below. Private donations received to date are \$88,799 (\$13,860 greater than the July report).

Confirmed Trusts and Foundations amounts include; Robert Salzer Foundation \$5,000, Cybec \$20,000, Playking \$40,000, Helen Macpherson Smith Trust \$25,000 and Besen Family Foundation \$10,000. Where possible new grants are being used to support existing planned activity however Playking and HMST grants have resulted in increased expenditure which is included in the Forecast.

8. COVID-19 support amounts outlined in the table below. The \$17,236 AusCo Resilience Fund and \$10,000 Creative Victoria amounts will support FQ's transition to digital platforms. FQ's JobKeeper benefit to 27 September 2020 has been confirmed; the financial benefit is estimated at approximately \$40,000 which has now been included in the forecast.
