### **PURPOSE:**

To provide the Board with an update of the 2023 Forecast, and to present the audited 2022 yearend Financial Statement for review and approval.

### **CURRENT CASH POSITION**

Flinders Quartet has \$262,469 cash on hand as at 12 April 2023 with \$13,500 restricted for specific committed purposes.

#### **2023 FORECAST**

- 1. The 2023 Forecast (refer to Attachment 1) presents a net surplus of \$901, which is a \$54 increase in surplus compared to the 2023 Forecast presented at the 9 February 2023 Board meeting.
- 2. Concert revenue forecast remains unchanged and comprises:
  - a. \$28,000 ticket sales target; \$1,027 has been received to date but recognised as "ticket sales in advance" (not revenue) until the concerts have been delivered
  - b. \$43,091 earned in concert fees to date; with \$42,500 target for remainder of 2023
- 3. Government Funding forecast of \$130,000 remains unchanged and includes:
  - a. Creative Victoria \$100,000; \$50,000 received, balance expected in second half of 2023
  - b. City of Melbourne \$30,000 (received)
- 4. Philanthropy revenue forecast of \$227,500 remains unchanged and includes:
  - a. Private donation revenue target of \$199,000, with \$15,744 confirmed and received
  - b. Trusts & Foundation revenue target of \$28,500 with \$13,500 confirmed and received
    - Canny Quine Foundation (Linda Herd) \$6,000 confirmed/received
    - Robert Salzer Foundation \$7,500 confirmed/received
    - Besen Family Foundation \$10,000 awaiting the outcome of the annual funding renewal application submitted late March
    - Lyngala Foundation (Anthony Adair and Karen McLeod Adair) \$5,000 personal approach to be made before EOFY
    - Other trust & foundation grant applications submitted but not yet included in the forecast include The Angior Family Foundation, The Charles Allen Foundation, Cybec Foundation, and Betty Amsden Foundation (to be submitted in April)
- 5. Recording revenue forecast increased in early 2023 due to a new recording project with Bryony Marks, resulting in an additional \$10,000 in income and expenditure (a \$0 impact to the 2023 bottom line).

- 6. Expenditure variations include:
  - a. Small reduction in musicians' salaries resulting from a minor adjustment to the number of days per diem a guest violinist is to be paid
  - b. \$10,000 increase in casual/project employee costs, related to the Bryony Marks recording project mentioned above
  - c. Small increase in guest artist (contractors) fees forecast
  - d. Small re-allocation administration budget to development to fund the purchase of Margaret Sutherland biography books to be used as donor gifts
  - e. Small decrease in marketing resulting from a change from print to digital marketing collateral

# **2022 AUDITED ACTUALS**

- 1. The 2022 year-end financials have been audited and the final Financial Statement for the year ending 31 December 2022 is provided as a separate paper for the Board's review. We will seek the Board's approval of these statements at the 19 April 2023 Board meeting.
- 2. A summary of the 2022 year-end position (and comparison to the current year budget and forecast, and prior year actuals) is provided in Attachment 1 and presents a net surplus of \$7,693. This represents a \$4,950 improvement on the 2022 draft actuals presented at the 9 February 2022 Board meeting, resulting from 2023-related marketing and insurance expenditure journaled into the 2023 year at the accountant's recommendation.
- In addition to the audited 2022 Financial Statements, the accountants have provided the following documents:
  - Board representation letter (provided in the meeting papers), attesting that the financial report is presented fairly and in accordance with Australian accounting standards; signed by Sandra Stoklossa on behalf of the Board
